Appointments, Postings, Transfers, Powers, Leave and other personal Notices and Orders.

NOTIFICATION

No. FE. 52/74-75/12-A, the 21st. February, 1975. The Lt. Governor (Administrator) of Mizoram is pleased to re-employs Shri G.K. Bhattacharjee, retired Accounts Officer of the Accountant General's Office, Shillong as Finance and Accounts Officer, Govt. of Mizoram as per re-employment rules for one year in the scale of pay of Rs. 350-30-500-EB-35-925/- p.m. (Pre Revised) plus other allowances as admissible from time to time under the rules with effect from the date of joining his duty and, further he is posted in the Office of the Principal Engineer, Govt. of Mizoram, Aizawl.

The term of re-employment will be for one year from the date his joining duty. During this period he will draw his last pay minus pension.

The appointment is made against the vacant post of Finance & Accounts Officer in the Office of the Principal Engineer, Mizoram Aizawl which was sanctioned under the Govt. of Mizoram; under letter No. PHE. 1/74/24 dt. 25. 7. 72 of Secretary, P.W.D., Mizoram, Aizawl.

Provided that the Administrator may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. **Training and Departmental Examination** Every Government servant shall undergo such training or pass such departmental examination as may be prescribed from time to time.
- 7. **Power to relax.** Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 8. **Reservation other concessions** Nothing in these rules shall effect reservation and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time in this regard.
- 9. **Repeal and Saving** All Rules pertaining to these posts, framed by the Governor of Assam or by the Govt. of Assam and were in force in the erstwhile Mizo District and continued to be in existence in pursuance of Govt. of India, Ministry of Home Affairs Notification No. 14/21/71-HMT (ii) dt. 21. 1. 72 are hereby repealed.

Provided that any order made or anything done or any action taken under rules so repealed or under any general orders ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.

ISSUED BY HEADS OF DEPARTMENT AND HIGH COURT

NOTIFICATION

No. LAD/Gen-47/74/76. the 21.2.1975. In exercise of the powers conferred by the proviso article 309 of the Constitution read with the Government of India, Ministry of Home Affairs Notification No. 14/11/71-HM I-(ii) dated the 21st January, 1972 and all other powers enabling him in this behalf the Administrator of Mizoram is pleased to make the following rules relating to the recruitment to the posts of Circle officers, and Town Engineers, Local Administration Deptt. Govt. of Mizoram, namely:—

1. **Short title and commencement** (1) These Rules may be called the Mizoram Local Administration Department (Class II posts) Recctt. rules, 1975.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. **Application.** These Rules shall apply to the posts specified in Column 1 of the Schedule hereto annexed.
3. **Number of Posts, classification and scale of Pay.** The number of the said posts, their classification and the scales of pay attached thereto shall be as specified in Columns 2 to 4 of the Schedule aforesaid.
4. **Method of Recctt. age limit and other qualification.** The age limit, qualifications and other matters relating to the said posts shall be as specified in column 5 to 13 of the said Schedule.

Provided that the upper age limit prescribed for direct recctt. may be relaxed in the case of candidates belonging to the Schedule Castes, the Scheduled Tribes and other Special categories of persons in accordance with the orders issued by the Central Govt. or Govt. of Mizoram from time to time.

5. **Disqualification** No person :
 - (a) who has entered into or contracted a marriage with a person having a spouse living, OR
 - (b) who, having a spouse living has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

NOTIFICATION

No. A. 12018/S7/80-APP(B), the 28th October, 1987. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram hereby makes the following rules further to amend the Mizoram Local Administration Department (Class II posts) Recruitment Rules, 1975 under Notification No. LAD/Gen. 47/74/76 dt. 21.2.1975 (published in the Gazette dt. 21.2.1975, Issue No. 7) namely :-

1. Short title and commencement
 - (1) These rules may be called the Mizoram Local Administration Department (Group 'B' posts) Recruitment (First Amendment) Rules, 1987.
 - (2) They shall come into force on the date of their publication in the official Gazette.

2. Under column 10 of the schedule of the Mizoram Local Administration Department (Class II posts) Recruitment Rules, 1975 (herein-after to as the said Rules) for the existing provisions in respect of the post of Circle Officer, the following proviso shall be substituted :-

"50% by promotion
50% by transfer on deputation".

3. Under column 11 of the schedule of the said Rules, for the existing provisions in respect of the same post, the following proviso shall be substituted :-

"PROMOTION : from Assistant Circle Officer having not less than 5 years regular service in the grade.

TRANSFER ON DEPUTATION : Officer of the Mizoram Subordinate Civil service in the scale of Rs. 550-900/- (pre-revised).
(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department shall ordinarily not exceed 3 years).
